Art. 1 Research grant (Postdoc position)

A public selection, based on qualifications and interview, is announced at the Department for Innovation in Biological, Agri-food and Forestry Systems of the University of Tuscia, for the assignment of 4 research grants to research activities for the disciplinary scientific sectors (s.s.d.) specified below:

no.1 - s.s.d.: AGR/14

Title of research grant: Greenhouse gas flows, soil quality and biodiversity in relation to the adoption of practices for sustainability in agricultural and agri-food systems.

Admission requirements referred to in the following art. 3, point 3: PhD (doctoral degree), or delivery of the PhD thesis, in agronomic, environmental, biological or forestry disciplines, 1 Publication in a journal valid for the purposes of the VQR. **Preferential titles**: Basics of programming, Basics of ecology, Knowledge and application of techniques and models of multivariate statistics.

Subjects of the interview: The interview of candidates will focus on ascertaining the level of competence in the research topic, in particular: Climate-environmental policy tools linked to the agricultural, agri-food and forestry context, data collection and processing for the definition of economic and environmental on a process, product and territory scale.

Duration: 24 months - Renewable

Research collaboration activities: The research fellow will be engaged in interdisciplinary research and analysis, where different skills (agronomic, ecological, pedological, food, landscape and socio-economic) will be used to analyze the performance of agro-ecological and agro-forestry systems conducted according to methods and schemes of production and processing that follow the most recent guidelines of climate and agricultural policies adopted in the company production contexts (see the carbon farming initiative) and in the supply chain (farm to fork strategy). The impact of the research will be to contribute to the promotion of protocols suitable for making the monitoring of the decarbonisation processes of the sector homogeneous and to incentivize the realization of efficacy assessments for measures and practices promoted by agri-food companies and developed within rural communities.

Art. 2 Tax, social security and insurance treatment

The provisions of current legislation are applied to the grants referred to in this selection announcement.

In the case of compulsory maternity leave and sick leave, the current legislation on the subject is applied. During the period of compulsory maternity leave, the allowance paid by INPS is supplemented by the university up to the full amount of the research grant.

The University provides insurance coverage for accidents, and for civil liability towards third parties in favor of fellowship holders as part of their research activity.

Art. 3 General admission requirements

Scholars in possession of a professional scientific curriculum suitable for carrying out research activities can apply for this public selections, with the exclusion of permanent staff of the Universities, institutions and public research, and experimentation bodies of ENEA., ASI, as well as the institutions whose scientific specialization diploma has been recognized as equivalent to the title of research doctor pursuant to art. 74, fourth point, of the Presidential Decree 11 July 1980, n. 382.

Those who have a degree of kinship or affinity up to and including the fourth degree, with a professor belonging to the Department or Structure requesting the activation of the fellowship or with the Rector, the General Manager or a member of the University Board of Directors cannot apply for this public selection.

Art. 5 Statements to be made in the application

In the application, the candidate, in addition to the surname, the name, the tax code and the precise domicile address, must declare, under his own responsibility, under penalty of exclusion:

- c) possession of the qualification required by art. 3 of the call for applications for admission with the indication of the University that issued it and the date of graduation.

Art. 6 Selection and formation of the rankings

The selection is based on qualifications and interview.

Forty (40) points are reserved for qualifications and 60 points for the interview.

In the first meeting, the commission establishes the criteria and methods for assessing qualifications and the interview to be formalized in the relative minutes to assign the relative scores.

The evaluation of qualifications, after identifying the general criteria, is carried out by the commission before the interview.

Candidates will be admitted to the interview if they have achieved a score of at least 20 points out of the 40 available in the evaluation of their qualifications.

The results of the evaluation of qualifications will be made known to candidates by publication on the website of the University of Tuscia http://www.unitus.it/it/unitus/albo-e-bandi/articolo/assegni-di-ricerca - DIBAF.

The interview will focus on topics relating to the research program for which the grant was announced and can also be carried out via the web for candidates domiciled abroad.

The commission has 60 points available for the interview; the test will not be considered passed if the candidate has not obtained at least 30 points out of the 60 available.

The interview will take place on SEPTEMBER 9, 2021, at 10:00.

The interview will take place via video and audio-conference, through the use of telematic technologies that allow the direct and auditory perception of the participants and the identification of candidates.

Any exclusion from the selection will be communicated exclusively by e-mail or Certified Electronic Mail (PEC).

The absence of the candidate from the test will be considered as a renunciation of the competition, whatever the reason.

To be admitted to the interview, candidates must present themselves, on the date of convocation, with, under penalty of exclusion, a valid identification document in accordance with the provisions in force.

At the end of each session dedicated to the interview, the commission draws up the list of candidates examined with the marks reported by each, which, signed by the president and the secretary, will be made known to the candidates by publication on the website of the University of Tuscia http://www.unitus.it/it/unitus/albo-e-bandi/articolo/assegni-di-ricerca - DIBAF and posted on the notice board of the exam venue in the case of an interview in person.

At the end of the selection, the commission draws up a ranking of merit in descending order by adding the score of the qualifications to that of the interview.

In the event of a tie between two or more candidates, the youngest will take precedence in the ranking. Research grants, as determined by art. 1 of this announcement are awarded to the successful candidates of the selection.

In the case of renunciation of the assignees or termination due to non-acceptance, the grants can be awarded to candidates who are found to be suitable, according to the order of the ranking.

It is also possible to draw from this ranking for the activation of new collaborations in research activities if, with a motivated resolution of the executive body of the research structure, on the proposal of the scientific manager, the affinity of the research is declared, it being understood that the minimum threshold for eligibility to acquire the title of research fellow is equal to 70 points.

The ranking will be approved by the Department Director and will be published in the Official Register of the University and on the website of the University of Tuscia http://www.unitus.it/it/unitus/albo-e-bandi/articolo/assegni-di-ricerca - DIBAF.

Art. 7 Examining Commission

The judging commission, appointed with the Disposition of the Department Director, will be composed pursuant to art. 5 of the Internal Regulations for the awarding of grants for collaborations in research activities.

At the end of its work, which must be completed within sixty days, the commission will draw up a special report containing the evaluation criteria, the judgments, the overall score attributed to each candidate and the merit ranking.

The judgment of the commission is unquestionable on the merits.

To ensure publicity regarding the composition of the examining commission, the Appointment Officer of the same will be published in the Official Register of the University and on the website of the University of Tuscia http://www.unitus.it/it/unitus/albo-e-bandi/articolo/assegni-di-ricerca - DIBAF.

Art. 8 Awarding of research grants

The fellowships are awarded by signing a private law contract signed by the Director of the Department. The contracts do not in any way constitute a subordinate employment relationship and do not give rise to any right regarding access to university roles. Grants can be renewable pursuant to Article 8, paragraph 2 of the University Regulations for the awarding of grants for collaboration in research activities.

Payment is made in deferred monthly installments of the same amount.

The payment of the last installment of the check is subject to the deposit at the administrative secretariat of the Center of the report provided for in the fourth paragraph of art. 11 of the Regulation.

The research fellow will be required to comply with the requirements of the University Regulations, which are published on the University website (http://www.unitus.it) in the page dedicated to the legislation.

Those who, within the established term, fail to subscribe or who do not take up service within the established term, lose their right to award the check.

The contract is terminated, on the motivated proposal of the research manager, approved by the collegiate management body of the relative structure, towards the research fellow, who after starting the planned research activity does not continue it, without justified reason , regularly and uninterruptedly or that is responsible for serious and repeated non-compliance.

The contract is also terminated for violation of the incompatibility regime established by the following art. 9, as well as in the event of a negative opinion expressed on the research activity, pursuant to art. 15 of the Regulation.

The research fellow has the right to request termination of the contract by formalizing a notice of at least 30 days. Termination begins on day 1 or day 16 of each month.

At the end of the contract, the grant holder must submit a report on the activity carried out, which, duly endorsed by the research manager, will be sent to the Research Office, through the Director of the Department.

The payment of the last installment of the check is subject to the deposit of the aforementioned report at the administrative secretariat of the Department.

Art. 9 Discipline of accumulation, incompatibility, expectations and interruptions

The ownership of the grant is not compatible with participation in bachelor's, master's or master's degree courses, research doctorates with scholarships or medical specialization, in Italy or abroad.

The grant, individual and indivisible, cannot be combined - under penalty of forfeiture - with other scholarships awarded for any reason, except with those granted by other national or foreign institutions useful for integrating, with stays abroad, the " research activity for grant holders, as well as with income from professional activities or employment relationships carried out on an ongoing basis. The exercise of freelance activities or the continuous performance of employment relationships is prohibited for the entire duration of the grant.

The carrying out of the activities referred to in paragraphs 1 and 2 entails the forfeiture of the contract. Without prejudice to the full performance of their duties, the holders of grants may request, exceptionally, to carry out assignments, also within the framework of University agreements, subject to the authorization of the collegiate management body of the relative structure, after consulting the opinion of the research manager, provided that the assignment:

- a) is occasional and of short duration;
- b) does not involve a conflict of interest with the specific research activity carried out by the research fellow;
- c) in relation to the activities carried out does not, however, prejudice the University.

The holders of grants who intend to carry out, or continue to carry out, a work activity involving services rendered free of charge in voluntary associations or non-profit social assistance cooperatives, can carry out this activity without the need for prior authorization, without prejudice to remaining, in any case, the full performance of its research tasks.

The employee serving in public administrations, holder of a research grant, is placed on unpaid leave.

The research activity and the grant can be suspended in the event of pregnancy and illness. These periods are not relevant, however, for the purposes of the overall duration of the grant. It does not constitute suspension and, consequently, an overall period of justified absence not exceeding 30 days in a year must not be recovered.

Integrative didactic activity of fellows

Research fellows can be entrusted with a limited supplementary didactic activity in the study courses, within the limit of forty hours for each academic year.
